



## NAMING CONVENTION

A new naming convention, in English language, has been created in order to make reading easy. Such a code points out whether the door is a landing or a car door, according to the following scheme:

1st Sign	L C	Landing or Car door = Landing = Car
2nd Sign	1 2 3 4 6	Number of the door panels
3rd Sign	S C	Closing side of the doors (side or centre movement) = Side = Centre
4-5th Sign:	/L /R	In case of side closing doors, after 3rd sign, a space bar comes before a further letter which stands for the closing direction: = Left = Right
Example:	L 2 S/ R	= Landing door, two panels, right side closing

















